# PARALLEL PROPOSED FSU-2.023, PUBLIC RECORDS: UNIFORM CHARGE PROCEDURE PROPOSED UNDER NORMAL ADOPTION PROCESS

FSU-ER21-3, Public Records: Uniform Charge Procedure [Emergency] FSU-2.023, Public Records, Uniform Charge Procedure

The amendment adds the university provided student email addresses to the university's definition of directory information, relevant to the Family Educational Rights and Privacy Act and state law, making such email addresses potentially subject to public record production, unless otherwise specifically requested by the student.

## SPECIFIC REASONS FOR FINDING AN IMMEDIATE DANGER TO THE HEALTH, SAFETY OR WELFARE:

These Emergency Regulations are necessary as recently observed needs for enhanced computer and information technology system efficiency and particularly for enhanced system and data security require this immediate change. It would allow the university to combine the student email system with the employee system to provide a single authentication identity for each student/employee, improved collaboration, remote instruction, consistent management, and particularly for enhanced security protection. Other SUS institutions also define student email addresses as directory information. This does not affect any existing privacy status of student emails themselves. This temporary emergency regulation will be followed by an identical proposed amendment with normal 30-day notice and comment period followed by Board of Trustees review and requested approval at its next meeting.

# **REASON FOR CONCLUDING THAT THE PROCEDURE IS FAIR UNDER THE CIRCUMSTANCES:** Adequate legal notice of the proposed action by the Board of Trustees was provided on the official Regulation webpage prior to the meeting and the matter clearly appears on the agenda for presentation to the Board.
